#### 4) Purpose and legal basis of the data processing:

#### 4a) Purpose of the data processing:

Your data will be collected to determine the number of participants. The number is needed to be able to organize and host the 2019 Nano-Bio-Physics Symposium. This event brings together scientists and biophysicists from all over the world with the aim of scientific exchange through lectures and informal discussions. The event will take place in Munich at the Ludwig-Maximilians-Universität and lasts two conference days.

#### 4b) Legal basis of the data processing:

Your data will be processed on the basis of Art. 6 Abs. 1 lit. a DSGVO, Art. 7 DSGVO.

#### 5) The recipients or categories of recipients of the personal data:

We will only process data that are collected from the participants. We will not disclose your personal data to third parties, to a third country, or to international organizations.

#### 6) Duration of storage of the personal data:

The data will be deleted as soon as they are no longer needed, which will be after the event. The deletion also takes place if the agreement will be disclaimed, unless a legal record obligation is required.

#### 7) Rights for the persons concerned:

You have the following rights, according to the General Data Protection Regulation:

If your personal data are processed, you have the right to obtain information about your personal data stored. (Art. 15 GDPR).

If there are personal data processed incorrectly, you are entitled to correct them (Art. 16 GDPR).

If the legal requirements are met, you will be able to request the deletion or limitation of the processing, as well as the objection to the processing (Articles 17, 18 and 21 DSGVO).

If you have agreed to the data processing or a data-processing contract and the processing of data is managed by using automated procedures, you may be entitled to data transferability (Article 20 GDPR).
